Dear Fellow Members.

Well, a new year is upon us, as our elections are over. I would like to congratulate our new officers Mike, Lisa, and Rich, and also our Trustees Gary, Rich, Sue, Gwen, Jack and Mercedes on their all being elected. And for myself, I thank you all again for your confidence in electing me for a second term as your President.

We had some major accomplishments last year. Our Charter renewal is almost complete, our 501c3 has been approved, and our first Grant application is in the works. The Fund Raising Committee is eager to start working, which will get the Grant money moving along.

The group is reaching one of our initial goals,



which was to obtain recognition by the Community. We were invited to give a presentation to introduce ourselves to the Pattersquash Creek Civic Association. A request was made for us to give a brief history of the local area to the Smith Point Village Exploratory Committee. We were invited by the American Legion to march in the Memorial Day Parade (see photo above) and we were asked to participate in the "National Night Out", hosted by the Community Summit in August. A year ago these groups didn't know we existed.

Over the past year, we hosted guest lecturers who gave presentations on the History of the William Floyd Estate, The Historical Homes in Brookhaven Town, The Tallmadge Raid, and on "The Effects of Colonialism on the Indigenous Tribes of Long Island". I have two more presentations scheduled for July and August, and an idea for another in November. These events go well with our group's purpose, and are liked by all.

The membership has easily doubled in the last year, and continues to grow. We have registered to participate in the Country Fair at the Longwood Estate, and will again march in the Chamber of Commerce Christmas Parade.

This year my goal is to look into the feasibility of obtaining a "Clubhouse", if that is what the group wants. All in all, it appears we will have an exciting year ahead of us, and I do look forward to leading our Historical Society onward.

Historical Society's Status Upgraded

Since 1999. The Mastic Peninsula Historical Society has been chartered by New York State Department of Education as the official Historical Society for the entire Tri-Hamlet Area. Our boundaries include all areas from The Carmens River to The Forge River, and from Fire Island to Middle Country Road. To mark our tenth anniversary, the Historical Society has undertaken an initiative to better serve our community by also applying for Federal recognition for our organization. This goal has now been achieved. Effective March 26, 2010, MPHS is now a federally recognized, tax-exempt public charity under section 501(c)3 of the tax code. As a result of this, henceforth, all contributions to the Mastic

Peninsula Historical society will be tax-deductible. Special thanks to MPHS member Andrea Milano and the members of the fundraising committee for their hard work on this project.

The Historical Society's next major project will be to raise funds and then hire an artist to create a map of historical sites within our charter region. Maps will then be distributed to the public in hopes of raising public awareness about the educational and cultural importance of preserving these historic sites. Publications Committee: The MPHS letterhead, membership application and membership brochure have been updated per our election results. An envelope template has also been created.


Historic Sites Committee: Thanks to the offer of a grant through the office of County Legislator Kate Browning and administered through the County Parks Department, work has begun to develop a map of historic sites within the trihamlet area. We are also making progress on a coventure with the Chamber of Commerce to get improved roadway signs to guide tourists to and from the historic William Floyd Estate. A written proposal has been drafted. Meetings have already been held with representatives of Brookhaven Town and of the National Parks Service. Meetings have yet to be scheduled with state and county officials.

Program Committee: At our May meeting, MPHS member James Reason was our guest speaker. He gave a presentation on "The Effects of Colonialism on the Indigenous Tribes of Long Island" and displayed tribal tools and weapons.

Fundraising Committee: The Society has successfully secured 501(c)(3) status (see article above). We have also submitted our application for the Hotel/Motel Tax grant. 
